#### Subject of the Disclosure

Result of the Special Meeting of the Board of Directors of NOW Corporation held on 28 July 2020.

#### Background/Description of the Disclosure

At the Special Meeting of the Board of Directors of NOW Corporation held on 28 July 2020, the Board approved the conversion of advances into equity of its shareholder Velarde, Inc. in the aggregate amount of Eighty Nine Million Pesos (Php89,000,000.00) with the conversion price computed based on Volume Weighted Average Price (VWAP) of the 30-day trading period ending 27 July 2020 or Php2.18 as reflected in the records of the Exchange, and the listing of additional shares resulting from the said conversion. With issue price per share at Php2.18, the conversion will result in the issuance of 40,825,688 common shares corresponding to 2.38% of the Company's outstanding shares.

Mr. Jesus Pedro S. Adan II tendered his resignation as Independent Director of the Company effective 28 July 2020. The resignation of Mr. Adan was not due to any disagreement with NOW Corporation on any matter relating to the Company's operations, policies or practices.

The Board elected Mr. Henry Andrews B. Abes as new Independent Director of the Company for the unexpired term of Mr. Adan, effective 01 August 2020.

#### **Other Relevant Information**

The report is amended to reflect the conversion price of Php2.18, the shares to be issued, and the resulting percentage to the Company's outstanding shares.
