Clarification of News Report

"PUBLICLY-LISTED company NOW Corp. announced on Monday its plan to acquire a substantial equity ownership in Newsnet, as part of its thrust to grow, consolidate and beef up its core business.

....

'Our dream is a minimum of 20 [percent of equity ownership] and a maximum of 100 [percent] over time,' he said, while citing their target of completing the negotiation before end of the year, either through direct investment, share swap, and preferred shares, etc.

...."

NOW Corporation confirms its plan to acquire equity ownership in News and Entertainment Network Corporation (Newsnet). The authority to initiate discussions with Newsnet having only been granted to the management on 03 October 2022 by the Board of Directors of NOW, the specific details of the contemplated transaction are not yet available at this time. The Company undertakes to promptly disclose all future material details/events pertaining to the planned acquisition.
